## **General Information:**

**BHA registration number required:** Register your dog on the Barn Hunt Association, LLC, website, <http://www.barnhunt.com>. BHA registration fee is \$32 and is a lifetime fee for that dog. There are no annual fees in Barn Hunt and no membership fee for dog owners.

**Entries:** Entries will **NOT** be accepted without BHA number, **SIGNATURE**, and payment. Owners are responsible for entry errors. Please write clearly and double check your entry for accuracy. The Barn Hunt Association, LLC, will not make corrections once results are submitted. Incomplete forms, nonpayment, and returned checks do not constitute a valid entry. Entries will not be considered valid without a signed Release Agreement Form. There is a \$25.00 fee for all returned checks. Initial confirmations of entry will be emailed to those listing a legible email addresses on the entry form. An After Closing Wait List will be maintained.

**Volunteers:** Volunteers are the backbone of Barn Hunt Trials. We need all hands to make a trial move forward. Volunteering is easy and fun! We will make sure you are instructed on how to do a job and you will get adequate time to walk your dog before your run. You always learn a lot when you volunteer! And, you will have the best seat in the house. Volunteer Raffle for toys, gift cards, and free Barn Hunt entry offered each day subject to change. Volunteers earn one raffle ticket for each blind worked.

**Refunds:** Refunds are ONLY allowed if requested before the closing date. No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, sick, excused, or barred from competition by action of the Event Committee. PayPal service fees are not refundable.

**Bitches in season:** BIS are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class. BIS must wear panties at all times (including on course) except in designated potty area. Entry fees for bitches that come into season will be refunded if owner wishes to withdraw if requested prior to the event. The Trial Secretary must be notified of any BIS as soon as possible. Failure to do so will result in a disqualification and dismissal from the event with no refund of fees.

**Leashes and collars:** Dogs must be on leash at all times within the designated show grounds. No Flexi-leashes are to be used coming into the ring. Electronic collars, bark collars, and head halters are not allowed to be used on trial grounds.

**Crating:** Owners of loud or disruptive dogs may be asked to cover their crates or relocate to another crating area.

**Dog aggression:** Any dog behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the trial if justification is found by the judge and/or trial committee. Entry fees will not be refunded.

**Crating:** Crating will be out of vehicles or within the 2 crating areas, both under cover.

All classes will be under a covered pole barn with rubber flooring. The ring is not temperature controlled.

**Blinds:** The blind is in an air-conditioned/heated 10' X 30' building, located 25' from the ring. Handlers are expected to be in or near the blind area so they can get into the blind as soon as the last dog in the blind enters the ring. We will not hold up a blind unless a handler was working in the ring. We ask that handlers not work the ring before their blind unless we are desperate for help. There will be 5-6 dogs per blind for Instinct/Novice/ Open, Crazy 8. Senior and Master will have 5. Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event.

**Soiled Bales:** There will be a fee per soiled bale. Current market cost is \$20 a bale. Please ensure your dog is properly pottied before entering the rings as to not incur this fee.

**Dogs in Attendance:** Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable disease, and have appropriate vaccinations.

**Awards:** Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. Ribbons will be awarded for first through fourth place in Novice through Master in each height division. Title ribbons will also be provided. High In Class for both A and B will be provided. Specialty awards will be offered at this event. If you are expecting to earn a RATCH or RATCHX, please notify the trial secretary 2 weeks before the trial.
