Any Judge of Record at this Event may be used in any ring. Qualifying scores will show the Judge who designed the Course.

Notice to Participants

It is expressly understood that participants alone are responsible for the behavior of their dogs and/or children. Any participant whose dog and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the event committee, be asked to leave the event site. In such case, no refund of any fees paid will be made. Des Miller, Marilyn Miller and its agents, employees, etc., will assume no responsibilities for any loss, damage, or injury sustained by participants or spectators, or to any of their dogs or property and further assumes no responsibility for injury to children.

Marilynn Miller reserves the right to decline entries for cause and may remove any dog because of dog or human aggression. No one shall have any recourse or claim against Marilyn Miller, Des Miller or any official thereof.

Exhibitor Information

Dogs must be leashed or crated when not actively working. Please pick up after your dog and dispose of waste in appropriate containers outside the building.

Ring Information/Location:

All classes will be inside a covered pole barn with rubber flooring. The ring is not temperature controlled.

Blinds:

There will be a 10' X 20' tent blind. Handlers are expected to be in or near the blind area so they can get into the blind as soon as the last dog in the blind enters the ring. We will not hold up a blind unless a handler was

working in the ring. We ask that handlers not work the ring before their blind unless we are desperate for help. There will be 5-6 dogs per blind for Novice/Open and Crazy 8's. Senior and Master will have 5.

Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event.

Safety: At all times, the safety of the dogs, handlers, and rats is to be of paramount importance. Rats will be humanely handled and safely confined in aerated PVC tubes; Barn Hunt is not intended to harm or kill rats.

Crating: Crating will be out of vehicles or within the 2 limited crating areas, both under cover.

Leashes and Collars: Electronic collars/devices and head halters are not allowed.

Collars in the Ring: Dogs may not be brought to the gate in any disallowed collar or on a Flexi-lead. Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced.

Bitches in season: Are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until the closing time if you wish to withdraw. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

Refunds: No event fee will be refunded if the event cannot open or be completed by reason of civil disturbances, fire, and act of God, public emergency, act of an extreme weather, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, sick, excused, or barred from competition by action of the Event Committee.

Refunds are ONLY allowed if requested before the closing date.

RELEASE AGREEMENT FORM

Certification of Agreement upon Registration or Entry of Dog

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above.
